Classification

REGULAR CLASSES

Junior Puppy	For dogs 6 months of age and under 9 months of age on the day of the show.
Senior Puppy	For dogs 9 months of age and under 12 months of age on the day of the show.
12 - 18 Months	For dogs 12 months of age and under 18 months of age on the day of the show.
Canadian Bred	For dogs born in Canada. Champions of any country are excluded.
Bred by Exhibitor	For dogs owned and handled in the ring by the breeder. The handler must be the owner / co-owner and breeder / co-breeder of the dog. The owner / breeder must handle the dog in this class but need not handle the dog for further awards.
Open	For all dogs.
Veterans	For all dogs 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered.
Specials Only	For dogs which have a recorded CKC registration or Event Registration Number and have attained the required points for championship status. All awards earned at the show will be cancelled if it is found that a dog is not registered or has not completed the requirements for a CKC championship. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy (if eligible).
Exhibition Only	A dog entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class may not compete in any Regular class but may enter and compete in Non-regular classes.
Exhibition Only 3-6 mths	For puppies 3-6 months of age may be entered in Exhibition Only, 3- 6 Months provided the Owner has also entered an eligible dog in a Regular Class. These Puppies may not participate in any regular, non-regular classes or Parades.

NON-REGULAR

Baby Puppy	For dogs 3 months of age and under 6 months of age on the day of the show. The awards for this class are: Best Baby Male, Best Baby Female, Best Baby Puppy in Specialty (Dogs in this class do not compete for Winners)

GENERAL RULES

1. The Show Superintendent will have full control of the Specialty Show, which shall be governed by CKC rules.
2. A judge officiating at a show held under CKC rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out.
3. Any dog excused by the Superintendent or Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
4. The show committee will use due care and diligence for the welfare of all dogs & Exhibitors but will not be responsible for, nor assume any liability in the event of accident or misfortune to dog or exhibitor regardless of cause.
5. It is expected that anyone participating in this show will be familiar the CKC rules pertaining to such an event. If you have any questions, a CKC Conformation Rule Book is available for viewing at the Show Secretary's table.
6. It is the responsibility of all exhibitors and/or handlers to have dogs at ringside when required for judging. Handlers are to report any absentees, and to have assistants at ringside if they have more than one dog entered and might be engaged elsewhere.
7. Entries will be acknowledged by email as soon as possible after the closing date.
8. All dogs are to be exercised only in designated areas. Failure to do so may result in dismissal from the show.
9. All dogs must be kept under control at all times.
10. Entries withdrawn in writing before the closing date and time will receive a full refund of entry fees. Entry fees shall not be refunded in whole or part after the closing date and time. In the event that a dog is absent, disqualified or excused by the Judge, Show/Trial Superintendent or Veterinarian, or barred from competition by action of the Show Committee, or because it has been incorrectly entered, no refund will be made.
11. All dogs not individually registered in the records of the CKC must pay listing fees.

Specialty Judge: Susan Godek

SUSAN GODEK – I have owned and exhibited German Shepherd Dogs for over fifty years. Surigo Shepherds have been exhibited in Conformation, Obedience, Tracking, and Herding, worked as service, search, and rescue dogs as well as assistance dogs. I owned and exhibited the first German Shepherd bitch to be awarded the Award of Excellence and ROM title by the GSDCA, bred and owned eighteen American Champions, seven Canadian Champions, and obtained eleven Select Titles. I served as President of The American German Shepherd Dog Charitable Foundation for thirteen years and as Director for five years. I served several years as chairperson for the GSDCA Junior Showmanship Program.

Judging for twenty years is one of the most enjoyable activities I have experienced in dogs. I presently judge the Herding Group, Working Group, Miscellaneous Group, Junior Showmanship, and BIS (in the US). I have judged in the United States, Canada, Mexico, and China. I attended Crufts Dog show in 2003 and the German Sieger show in 2004 and 2005. I judged Best of Breed at the German Shepherd Dog Club of Canada 2012 National Specialty.

I am a member of the German Shepherd Dog Club of America, German Shepherd Dog Club of Canada, and Life member of the Grand Canyon German Shepherd Dog Club, Scottsdale Dog Fanciers, and Phoenix Field & Obedience. I belong to the American Dog Show Judges, Dog Judges Association of American, Senior Conformation Judges Association, Western Dog Judges Association of America, Scottsdale Dog Judges Workshop, Working Dog Club of Arizona, Stewards Club of Arizona, and Oregon Dog Judges.

I have attended many educational seminars and Institutes including the AKC and ACEF Judging Institutes, the AKC and ACEF Advanced Herding Institutes, the AKC and ACEF Advanced Working Institutes, the ACEF Advanced Toy Institutes, the AKC and ACEF Advanced Working Institutes, the

Vonderbrink German Shepherds

I grew up with German Shepherds as a family pet. (My father gave my mother a GSD puppy as a wedding present.) It wasn't until I met a colleague in the late 1970's who bred, trained and showed champion Cockers that I was introduced to the world of show dogs in both obedience and conformation. My first venture into conformation did not produce a show dog but did produce a wonderful pet. My second attempt at buying a show dog ended in my buying a Covy-Tucker Hill Finnegan daughter. Mary Roberts finished her and I had my first American champion and CD.

I moved to Canada in the late 80's with 3 GSDs, and on the advice of my handler, Anne Koots, I bought a finished show dog: Morningold's Local Echo. She became the foundation bitch for Vonderbrink kennels. My adventures in showing, breeding and competitive obedience really began with Echo.

Echo produced several litters, the first by Ken-Delaine's Taylor Made, followed by 3 litters by Rockannand's Integra, and a last litter by Khaskova's Midnite Marauder which produced my Best in Show bitch Vonderbrink's Hester. Hester produced 2 litters by Sandyhill's Jimmy Nevada and her last litter by Altana's Outlaw. My last litter was by Hester's daughter Johanna and Khaskova's Midnite Marauder.

Out of these litters came several champions, CD's, group winners, reserves and winners at specialty shows, several BPIS and one BIS. Although showing my dogs was endlessly fascinating, the best part of my life has been living with GSDs.
